OLD BUSINESS:

The Minutes of the April 14 Dinner Meeting were reviewed as written in the newsletter and approved.

In the absence of Treasurer Pam Albertson Joanne Turner-Chiacchia presented the Treasurer's report. Overall the club donated \$18,060 in support of service activities during this past year. Going forward we have \$14, 076 to offer for service this coming year. Both are great accomplishments for a small club. The proposed budget for FY 2015 was approved and the Treasurer's Report was filed for audit.

NEW BUSINESS/COMMITTEE REPORTS:

Nominating Committee: Outgoing Nominating Committee Chairman Marge Cavanaugh proposed the following members for 2014-2016 Nominating Committee: Mary Knight, Loretta Dansereau and Dana Burton. Club members approved the nominees.

Service Committee: Chairman Loretta Dansereau made a motion that we donate \$250 to Zonta International in support of the 5K Run that Convention Delegate Mary Knight is participating in at the International Convention. The motion passed.

Veterans Visit: Janet and Desiree are coordinating the visit on June 17th to the Vets cottage to help in a planting project. Members are encouraged to contact Janet or Desiree if they plan to attend. We received some grateful thank you notes from the Veterans in regards to the trip to the Magic Wings Butterfly Conser-

vatory. Our newest member Sandy Goss recently hosted 5 women for manicures and pedicures at her business. It was a real treat for the ladies and Sandy plans to offer them on a regular basis.

Silent No More Auction: Chairman Dianne recapped the very successful event held last month. In addition to the receipts from the auction items which amounted to \$5844, Dianne added that the Soldier On Vets received an additional \$1500 and the Carson Center an additional \$500. One of the Vets was spontaneously offered a position at the Carson Ctr. once she completes her education. A real bonus to the evening.

J.M Klausman Award Winner: Kris announced that Elizabeth Fitzgerald who is attending Our Lady of Elms College was selected.

Golf Committee: Chairman Debbie recapped the plans for the Sept. 13th 20th Annual Golf Tournament. The need for sponsors, players and prizes was reinforced. A task sign up form was submitted for members to help prior to and the day of the tournament. The names of the lucky raffle winners were: Janet DaSilva (Red Sox tickets), B.J. Bourdon (T.V.) and Walter Parzychowski, a P.O. employee won the \$100 Lottery tickets. Debbie is pleased to announce that \$1100 was raised by the raffle.

June/July International Convention Delegate: As delegate to the Convention Mary Knight reported that the main focus in the 2014-2016 proposals is preventing root causes of violence against women through education. The proposals will focus on delaying early marriages in Niger, supporting gender responsive schools in Vietnam, eliminating obstetric fistula in Liberia and HIV-Free generation in Rwanda. As well the ZISVAW initiatives will involve Voices Against Violence in 12 countries. Mary mentioned some of the Candidates who will be running for office including our very own member Mary Ann Rubis who hopes to be elected to International Director and Lynn Goodhue who is a candidate for the International Nominating Committee. Mary Knight briefly mentioned that there would be a number of bylaws proposed changes and she highlighted that "It is proposed that clubs with 30 (instead of 40)members will be entitled to a second delegate and clubs with 60 (instead of 80) will be entitled to a 3rd delegate. The change reflects the average club membership decline and is seen as a mechanism to generate more activity and interest. Some of the proposed amendments make clarification and title changes to the list of Standing Committees. Wording regarding membership changed to:

(1.) Membership shall be drawn from women and men with experience in a recognized business or profession (actively engaged in a decision making capacity is removed.(2.) Mary plans to review the proposals in more detail so she will be prepared to vote at the Convention. She is carrying proxies from 2 other clubs in addition to ours.



Membership

Can you imagine being a member of a district that consists of nine countries, speaking more than six languages, extending from the United Kingdom to Russia? While the opportunity to network with such a diverse group of women would be wonderful, conducting district business, conference and area meetings, would be quite challenging. This biennium, ZI will begin the process of redistricting, looking at the compilation of each district to determine how it can function more effectively within Zonta. European Zontians will meet in Copenhagen in September with members of the Zonta International Board (ZIB) and the European members of the Zonta International Membership Committee (ZIMC) to share their thoughts on redistricting. Due to the large and multi-cultural districts in Europe, the ZIB decided to begin the task in this region.

How would redistricting affect our District (D1)?

Currently, D1 has approximately 322 members. Our district's membership has steadily declined for many biennia. In order to remain a District, we must have more than 300 members. ZI is concerned that D1 may fall below that level during this biennium. According to the bylaws of Zonta, if this were to occur, we would no longer be a district, but a region. As such, we would no longer have a governor, an international representative at our official fall conference, or a vote at convention. The ZI President would appoint a member from our region to serve as a Regional Representative, who would work closely with the ZIB to regain district status. Redistricting could also mean that D1 would merge with another district, perhaps D2 which includes clubs in New York.

Increasing membership is a huge challenge for all international service organizations, not just Zonta. Now is the time for all D1 members to "dig deep" and make membership a priority.
